

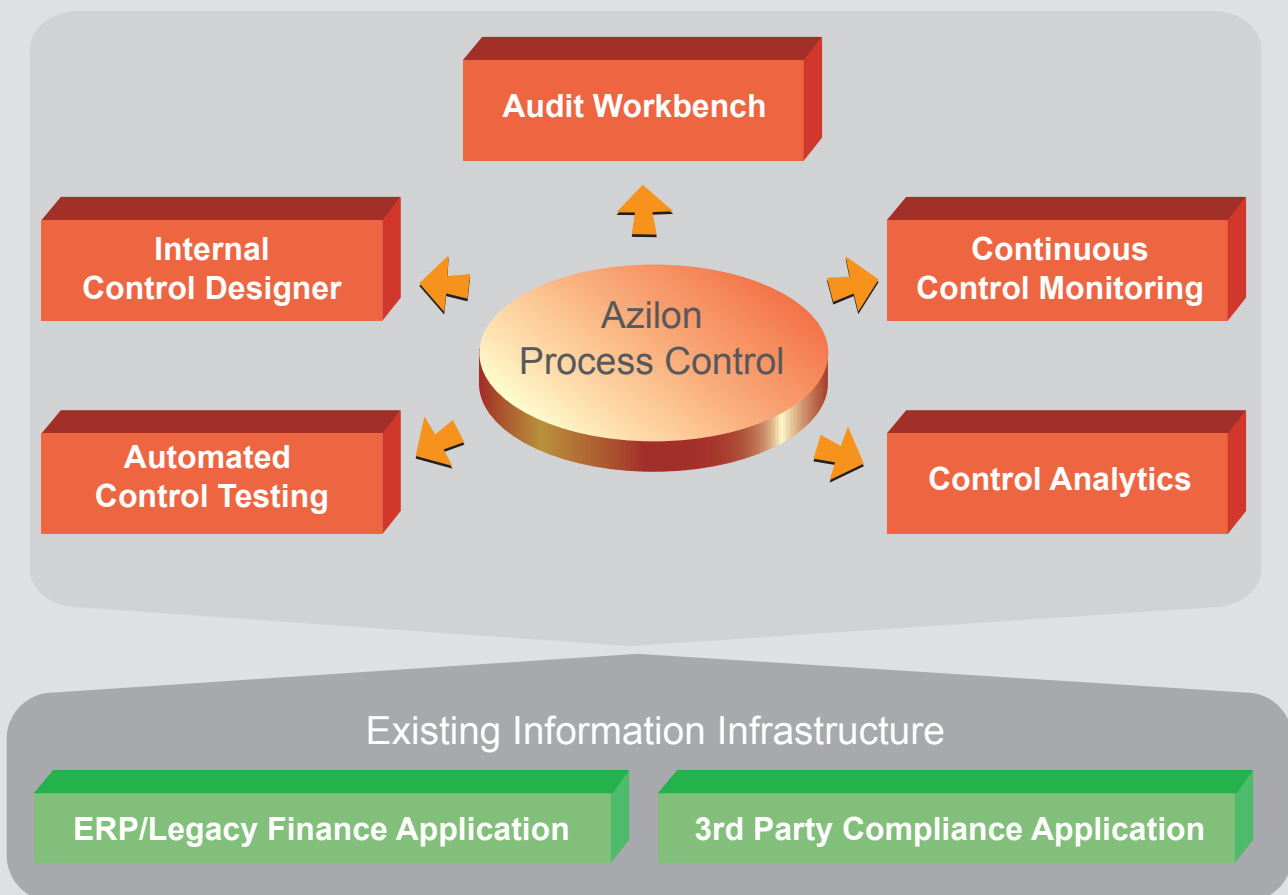

Process Doc

Control Monitor

Control Enforcer

Azilon's Control Enforcer is an automated solution that enforces policies on a real time basis. In organizations, transactions are usually executed either directly by users or through EDI media. The Control Enforcer intercepts these transactions on a real time basis, checks for any violations and reports them, with the help of a powerful policy engine. The system can then either prevent the transaction from being executed or it can initiate the workflow for gaining approval, so as to continue the transaction, the choice of procedure being dependent on the organization's policy.
